HED 0102 - HEALTH AND SOCIAL JUSTICE

Advisory: Eligibility for ENGL C1000

Hours: 54 lecture

Description: Provides an introduction to the health inequities in the United States that stem from unequal living conditions. Students will explore how education, socioeconomic status, racism, and gender shape health epidemics and policy development. Fundamental theories to advocate for health and social justice will be explored, and community organizing approaches will be practiced. (C-ID PH 102) (CSU, UC)

Course Student Learning Outcomes

- CSLO #1: Compare a public health model that considers structural, social and economic determinants to an individual lifestyle and behavior change model to explain disparities in prevalent health conditions.

- CSLO #3: Analyze the contribution of social inequality, economic inequality and environmental conditions to disparate health outcomes.

Course Objectives

Upon successful completion of the course, students will be able to:

- 1. Describe disparities in health outcomes in the United States by race, socioeconomic status, and gender.
- 2. Compare and contrast the two paradigms that seek to explain health disparities: the individual approach and the public health model.
- 3. Compare United States healthcare policies with that of other developed countries and contrast the characteristics of each system.
- 4. Analyze the contribution of environmental conditions to disparate health outcomes, using case studies.
- 5. Describe the connection between environmental justice and disparate health outcomes based on race, class, and gender.
- 6. Analyze case studies of prevalent health problems to compare individual behavior change approaches versus public health approaches.
- 7. Describe strategies or tactics to improve health inequalities, such as advocacy, community organizing, and/or policy change.
- 8. Demonstrate advocacy skills, such as outreach, organizing, and mobilization of communities to improve health outcomes.
- 9. Identify, assess, and utilize credible information resources on public health current issues, such as the Internet, social media, media outlets, and libraries.

Methods of Evaluation

- · Classroom Discussions
 - Example: Classroom discussion on previous and emerging current event topics inn the area of health and social justice
- · Objective Examinations
 - Example: Quizzes and exams will be used that measure the student's ability to analyze health and social justice problems including health disparities, social injustices in healthcare provision, etc., and to evaluate the efficacy of various medical and population-based methods and services for addressing these issues. For example, list 5 of the greatest public health achievements in the last century according to the Center for Disease Control and Prevention.
- Proiects
 - Example: Individual and group projects that demonstrate understanding of the disparities in health provision, accessibility, and outcomes, and the role of society in addressing these issues (as well as demonstrating appropriate use of reliable print and internet resources). Students will create a project (multiple

Lecture:

 Instructor-led group discussions and case studies on topics such as the health/wealth gradient, race/ethnicity and gender privilege in the US, environmental justice, access to education, and health outcomes based on employment and housing

Distance Learning

1. A class discussion prompt will be given asking students to reflect on the impact to the public from the period of time of the onset of the Covid 19 pandemic to today. The students will be given an article to read "ENOUGH: COVID-19, Structural Racism, Police Brutality, Plutocracy, Climate Change—and Time for Health Justice, Democratic Governance, and an Equitable, Sustainable Future." Students will then be asked to reflect on how the intersection of identities and social determinants of health impacted various communities differently. The instructor will engage in the thread providing probing questions or giving examples to help connect the points of the article to textbook reading and previous class discussions and content.

Typical Out of Class Assignments Reading Assignments

Reading assignments on topics such as racial income and wealth disparity (health/wealth gradient), access to education, health outcomes based on employment and housing, disparate impact on communities of various illnesses (e.g. cancer, COVID-19, asthma, lead, diabetes, heart disease). The students will then be asked to outline and discuss the main points of the reading that demonstrate the connection between social determinants of health in various communities and disparate health outcomes.

Writing, Problem Solving or Performance

Written assignments such as community walk-through and letter to policy maker or news editor.

Other (Term projects, research papers, portfolios, etc.)

Final research paper on a social determinant of health connected to a health disparity, including etiology, epidemiology and proposals for institutional or policy change
